Trustees

The Trustees presented a proposal to engage a new sub-committee of the Trustees which focuses on interior design standards. The guidelines will serve as a charter and framework under which the Interior Design Advisory Subcommittee (IDAS) will operate. These guidelines incorporate the following principles:

- 1. Welcoming Environment
- 2. Standard Color Palettes and Uniformity

The IDAS's first focus will be to develop standard color palettes, which will provide the paint colors which can be used in the defined areas of the church. These color palettes will be presented to the Trustees and the Church Council for consideration and approval. Any painting projects for the church properties will then be selected from the color boards. No paint colors should be changed without following this process.

Action Item: For the September meeting, the Trustees are to meet with the Endurability Committee and develop a communication plan including:

Presentation deck for Church Council, which could then be shared with the congregation

- 1. explain the process followed by the Endurability, the recommended priorities and reasons
- 2. recognition of the needs shared by the congregation in the earlier survey, which ones are going to be included in the plan, and which ones are not and why
- 3. roadmap and next steps
- 4. Communication and update plan
- 5. The progress will be a standard agenda item for the Trustees to provide a formal update to the Church Council of actions taken and progress made
